<p>In addition to the above requirements, the skilled professional such as pharmacists, applying to work in Fiji shall provide the following upon request:</p> <p>i) Curriculum from the University⁵ which shall include the following:</p> <p style="margin-left: 40px;">a) Covering letter from the University which gives a brief description of the degree/program (Duration of the degree/program, delivery mode, number of courses, total credit points)</p> <p style="margin-left: 40px;">b) For each course or unit taught a course outline which should have:</p> <ul style="list-style-type: none"> • Course/Unit description with credit points • Learning Objectives • Method of Assessment for the course <p>ii) A Certified copy of the Annual Practising Licence</p> <p>iii) A Certified copy of the Registration Certificate</p>
